

DHL Youth Volunteer Fellowship Award: Official Rules

If you're a change-making, go-getter, this program is for you! DHL and WE are teaming up again to recognize and celebrate exceptional young students who are leading their generation to change the world with the DHL Youth Volunteer Fellowship Award. Thanks to the generous support of DHL, this award gives you the chance to grow as a leader and continue on your path to do great things in your community. . To celebrate and recognize their achievements, the DHL Express U.S. and WE Charity (the "Presenters") have joined forces to create the DHL Youth Volunteer Fellowship Award (the "Award").

Sponsored by the DHL Express U.S., the DHL Youth Volunteer Fellowship Award was created to highlight the incredible work of youth across the U.S. and celebrate their commitment to changing the world through service, volunteerism, and action. DHL and WE want to give you the resources, mentorship, and opportunity to grow as social leaders and help create positive change.

This honor is given to those who have distinguished themselves by volunteering their time and creativity through active engagement in their communities and the world we live in. They will have the opportunity to nurture and grow their philanthropic spirit through ongoing mentorship and engagement with the cause for which they are passionate.

The Fellowship encourages lasting commitment to social action by America's youth.

HOW TO APPLY: To apply for the Fellowship, eligible persons must complete and submit an application found at WE.org/DHL, between the dates of September 26th, 2018 and April 30, 2019 (the "Eligibility Period"). While such action is not mandatory, applicants are encouraged to submit reference letters and creative submissions (e.g., videos, photographs, works of art, written submissions, etc.) (collectively, the "Additional Submissions") during the Eligibility Period to weschools@we.org or ATTN: WE Schools, 339 Queen Street East, Toronto, Ontario, M5A 1S9. Additional Submissions must include the applicant's full name. Applications and/or Additional Submissions that arrive outside of the Eligibility Period (i) are incomplete, or (ii) otherwise do not adhere to these Rules and Regulations, may be disqualified at the sole discretion of the Presenters.

ELIGIBILITY: Individuals are selected for the Award based on the following criteria. Individuals must:

- (i) be a student between thirteen and eighteen years of age at the time of entry;
- (ii) be a resident of the United States of America and enrolled in a school located in one of the following US States: Texas, Minnesota, Illinois, New York, Washington, or California;
- (iii) must have a U.S. passport which is valid to February 2020, and must be able to travel internationally;
- (iv) must complete and submit an online application answering all four (4) questions at WE.org/DHL;
- (v) if under eighteen (18) years of age at the time of entry, must provide consent from a parent/guardian to accept the Award if so selected; and

(vi) Employees of WE Charity, ME to WE Social Enterprises Inc. (“ME to WE”), DHL Express U.S. (“Sponsor”), or their respective affiliate companies, as well as the immediate family (spouse, parents, siblings, and children,) and household members of each such employee are not eligible to enter.

AWARD DETAILS:

Six (6) separate Awards will be provided to selected recipients. Award recipients will be honored with the following:

- A ME to WE Youth Trip to Ecuador in August 2019; the trip will include flights, accommodations, food, and in-country ground transportation;
- A dedicated WE Schools mentor will be assigned to provide guidance and tips to help execute the Action Plan;
- The opportunity to attend their local WE Day and present on stage; and
- An opportunity to attend a leadership workshop with senior members of both DHL and WE to learn firsthand from accomplished social leaders.

CRITERIA: Nominees will be evaluated by the use of consistent criteria when considering each nominee.

- Degree of their dedication to taking action;
- Degree of their passion for their selected causes or issues; and
- Degree of how they have successfully created positive change locally or globally.

AWARD CONDITIONS:

Individuals that are selected as Award winners must agree to the following conditions to accept the Award:

- i. Application must be received by the application deadline of April 30, 2019; and
- ii. Each recipient is responsible for his/her own travel insurance, vaccinations, transit visas (if applicable) and valid passports.

NOTIFICATION OF AWARD RECIPIENTS: Selected nominees will be notified that they are selected as Award winners by email no later than June 13, 2019.

RECIPIENT CONSENT

By accepting the Award, the recipient (and parent/legal guardian for recipients under the age of majority) agrees to the following:

- a) Information contained in the nomination may be made accessible to the public on the website and promotional items produced by the Sponsors;
- b) Information about the recipients, including without limitation their name, school, and region may be made accessible to the public on the website and promotional items produced by the Presenters;
- c) For promotional purposes, in perpetuity and in any form of media worldwide now or hereafter devised without additional compensation or permission unless prohibited by law, the Presenters may copy, reproduce, use, reuse, license, exhibit, display, distribute, and create derivative works of: (i) any creative submissions provided by the recipient; (ii) the recipient's likeness, photograph, or voice; and (iii) statements made by the recipient regarding the Award;
- d) To be fully and unconditionally bound by these Official Rules; and
- e) To accept the decisions of the jurors as final and binding as it relates to the Fellowship.
